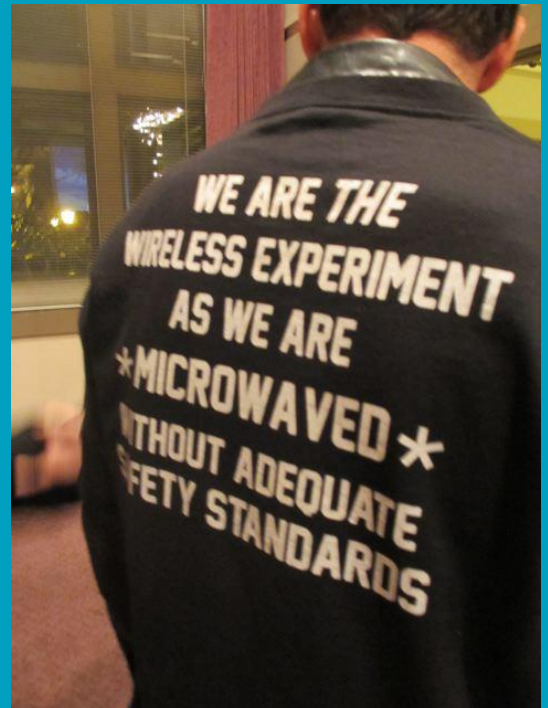




## The FCC "delivered" to industry - risking the public's health

Greetings!

The Federal Communications Commission (FCC) on July 14, 2016 voted unanimously to rollout the [5G network](#) without regard to the health considerations. The Center for Safer Wireless worked hard to stop this unfortunate event. Our staff went to relevant congressional offices advocating our position to put our health ahead of industry profit, and you supported our position by writing letters to the FCC.

Despite these efforts, we sat at the FCC meeting on July 14 and watched as the FCC Commissioners, one by one, spoke about the wonder of 5G, totally ignoring the written comments and cries for help from people who are negatively affected by wireless radiation and suffering daily because of our wireless world. The countless letters citing scientific studies showing biological harm from wireless radiation did not even cause a

casual mention from the Commissioners. They also chose not to acknowledge the recent \$25 million U.S. National Toxicology Program preliminary rat study showing a link between cancer and wireless radiation. There was no acknowledgement of the many letters telling Commissioners not to blanket the country with the 5G wireless radiation, which has never been tested for safety. Silence was our reward for commenting while the telecommunication industry is in a position to greatly benefit from the FCC's promised "Internet of things" which means [everything on mobile](#). Industry profits will abound from having a cell antenna on every utility pole and endless devices to sell to the public.

The FCC went to great lengths to make sure we could not speak out against the network. Activists tried to put up a sign and display t-shirts about the wireless radiation hazards. They also tried to speak to the Commissioners after the FCC meeting, but were stopped by security guards who used intimidation. A Bloomberg reporter's credentials were confiscated because he spoke with Kevin Mottus, one of the activists.
